

Welcome and thank all for coming to MinnePaul's MAAD Basketball.





I gave the annual summary of the financial report. The checking balance on December 31, 2010 was showed \$23,731.58. We realized that the MAAD had been spent a lots of money on the officers expenses, retreat and agent's expenses. The Merrill Lynch Report ending on December 31, 2010 showed \$18,491.88. It was good to increase \$1,552.28. I find that I am in need of a financial budget committee. There was also some confusion on why LAD had to pay \$100 check and was told that it was because LAD didn't have a team after hosting in 2009.

Currently, we have a total of 12 teams coming and play ball at Hamline University in St. Paul, Minn. All together there are 146 players and coaches participating in the games.

I hope more fans will come and watch these amazing games, however, we recognized that the United States of America Deaf Basketball (USADB) hosts the deaf national basketball in Bloomington, MN on March 30 – April 2, 2011.


May the best team win and represent our region in either of two (2) national tournaments.







I am excited about the tournament. 8 men teams and 4 women teams are entered in our tournament. We will use 2 courts for 1st and 2nd rounds. Then change over to main court with shot clock for last 3 games on Saturday afternoon. The gym temperature will be warm! Be sure to dress comfortably and bring your water bottles!

We purchased tournament liability insurance through K & K insurance. Most insurance companies only provide coverage for youth sports. It was hard to find coverage for adult basketball, but we were able to do it.

There is an athletic trainer on duty for the whole weekend. Her name is Amara and she will be stationed in MP committee room in the SW corner of the gym. She is hearing and does not sign, so be polite and she will serve you better!

Wristbands will be worn by fans from beginning of tournament to the end on Saturday night. Players, delegates, committee and board members will get name badges to wear. After teams are eliminated, players are expected to put on wristbands otherwise they will not be admitted to gym or Saturday night party. Replacing lost or damaged wristbands with proof of purchase is \$10. No proof? Pay full price!

I am very disappointed with the lack of sponsors for trophies. It seems to be a disturbing trend within MAAD. If this keeps up, our future trophies will just be a printed piece of paper!

4 Booth sponsors are: Canadian Diamond Traders, Convo Communications, ZVRS, and Purple. Be sure to visit their tables and see their products and services!


We will be selling \$1 raffles throughout the tournament and the drawing is planned for Saturday night March 5th. Look for the yellow color!


