- Happy about the bracket drawing, satisfied

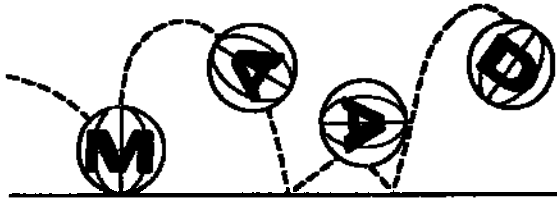
### **Secretary Lynda Collicott-**
