Show check that MAAD already paid back the membership fee (#2498)

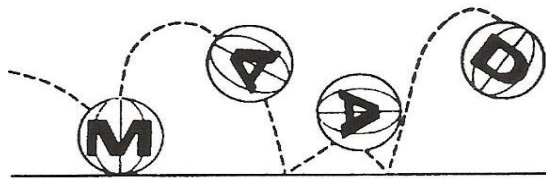
Parking \$10 issue
